Kano: Police raise alarm over plots to import thugs to disrupt polls

• Warns trouble makers to steer clear or face full wrath of law

KANO—THE Kano State Police Command, yesterday, raised the alarm over plots by some disgruntled politicians in the state to import thugs to disrupt Saturday governorship

Mamman Dauda who raised the alarm in a statement through the command's spokesperson, Abdullahi Haruna, warned thugs and other trouble makers to steer clear of the state or face the full wrath of the law

KANO—THE New Nigeria Peoples Party, NNPP, and the Kano State government are accusing each other of plot to disrupt Saturday's governorship election

election.
While the NNPP accused
Governor Abdullahi Ganduje and
the state Director of Department
of State Services, DSS, Albassan

of State Services, DSS, Alhassan Muhammad, of planning to disrupt the poll, the state government vowed to check any attempt by NNPP to rig the governorship and state assembly elections in the state.

NNPP in a statement vesterday read by the Senator-elect representing Kano North Senatorial Zone, Dr Baffa Bichi, claimed the party has details of plans by the duo to use hired bandits across the state,

organized delays of sensitive materials and plan to disrupt collation centres. The party further alleged that there is also plan to compromise Law Enforcement Agencies, engage in massive vote buying and voter intimidation, selective arrest and intimidation of NNPP leaders.

Among others, NNPC said "We are therefore writing to draw the attention of the President Commander-in-Chief and indeed all the authorities concerned to be in full knowledge of these ungodly plans and to take every necessary action to ensure the protection of lives and property, to ensure the peaceful and credible conduct of elections, and to ensure that the brewing crisis in Kano State is averted and Ganduje and his collaborators are not allowed to kill even more innocent citizens because of their desperation to cling to power.

"We are aware that thousands of bandits from Chad and Niger

republics as well as from Katsina and Kaduna states have been hired and brught into Kano state by the Gandujiya administration to be used to disrupt the elections. The DSS and the Nigeria Police are aware of this. These bandits, brandishing heavy weapons including guns and machetes, are already in different locations across the 44 local government councils. Nigerian government and indeed all Nigerians should be aware that for any breach of the peace on Election Day, governor Ganduje and his gang including the Kano Director of the DSS (who ought to have retired from the service over a year ago) must be held personally responsible. Law enforcement agents must be proactive in taming this unfortunate menace and averting this senseless disaster that is being planned against the good people of Kano State.

"It is also worthy of note to inform you that Mr. Ganduje has granted pardon to a number of republics as well as from Katsina

convicted murderers who were sentenced to death by competent courts of law. Only late last year he commuted the death sentences of these murderers to life imprisonment and last week he granted pardon to all of them. We are raising this, because are aware that Kano State government has raised a team of government officials to travel to the correctional facilities where these murderers are serving their

government officials to travel to the correctional facilities where these murderers are serving their sentences to collect them, return them to Kano to join the gangs of bandits with the intention of terrorizing the good people of Kano and disrupting the conduct of the March 11, 2023 elections."

Responding, the Kano State government dismissed NNPP's allegations, insisting that it is the opposition party that is planning to check any attempt by NNPP poperbutate any form of electoral fraud

The government in a statement by the Commissioner for Information and Internal Affairs, Malam Muhammad Garba, said government has received credible information on how thugs will be hired from villages in Kano and beyond to upset the electoral process through violence, massive rigging, box snatching and arson.

Garba recalled that in 2019, the opposition managed a well organised election rigging network, particularly in the metropolitan local governments, where youths, mostly without voter cards, were engaged to perpetrate the act.

The commissioner alleged that this time around, the opposition was planning to bring chaos through the use of thugs to cause maythem with a vew of dispersion voters at polling units in order to

CSOs, others kick as Reps Majority Leader, Doguwa, gets bail

KANO—A Federal High Court sitting in Kano, yesterday granted bail to the Majority Leader, House of Representatives, Alhassan Doguwa standing trial over alleged complicity in the murder of three members of his

on three memoers of his constituency.

The police in Kano arrested and charged Mr Doguwa, alongside others, for criminal conspiracy, culpable homicide, unlawful possession of fire arms, mischief and incitement of public disturbance.

Recall that Doguwa was arraigned before a Senior Magistrate court by the Kano State Commissioner of Police and was later remanded in prison till 7th March, 2023.

The Presiding Judge, Justice Yunusa Muhammad granted Doguwa bail following an exparte application for the enforcement of Doguwa's rights by his counsel, Nuraini Jimoh before

Jimoh had prayed the court to

admit the defendant on bail, arguing that his client is presumed to be innocent, pursuant to the provision of section 35 subsection 6 of constitution of Federal of Nigeria

constitution of Federal of Nigeria (1999 as amended). Ruling on the application, Justice Muhammad granted the application with N500 and two reliable sureties in like sum.

The Court said the sureties shall be first class emir and any senior officer in civil service.

Justice Muhammad similarly

ordered Doguwa to drop his International Passport to Court Registry pending the trial. The Court also restrained the

defendant from going to his Constituents during the Gubernatorial and state House Assembly elections billed to hold on 11th March, 2023.

Meanwhile, Kano State Civil Society Forum and some concerned citizens have kicked against the bail granted to Doguwa by the cor

The Forum's Chairman, Ibrahim Waiya, while briefing newsmen threatened to challenge the matter before International Court of Justice and International Human Right Commission, saying the matter would not be swept under the

carpet.

According to him, "this is just the beginning of the case. The matter will not be swept under the carpet as we will follow up to logical conclusion. We will challenge the matter before International Court of Justice and International Human Right Commission for redress." Commission for redress.

Earlier, some concerned citizens of Tudun-Wada LGA who got wind of the unfolding development to secure bail for Doguwa had beseiged the Federal High Court to protest

the move.

The aggrieved citizens v The aggneved citizens were seen displaying placards with inscription such as "We need Justice for T/Wada people", "Public is watching Alhassan Ado Doguwa", "Right to life is constitutional" and "No bail for Alhassan Ado Doguwa," among others
